2023-24 Financial Year listing - Senate Order Listing of Entity Contracts

Pursuant to the Senate Order on Entity Contracts, the following table sets out contracts entered into by the Indigenous Land and Sea Corporation, which provide for a consideration to the value of \$100 000 (GST Inclusive) or more and which:

TS: Trade Secrets/Intellectual Property	Disclosure would reveal intellectual property or trade secrets that are judged to have the potential to cause detriment to the contractor.
